

**YOUR ONE DAY AT DISNEY SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT
OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. **SPONSOR:** Disney Destinations, LLC (“Sponsor”), P.O. Box 10000, Lake Buena Vista, FL 32830.
2. **ADMINISTRATOR:** Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033, U.S.A., is the independent agency administering this Sweepstakes.
3. **ELIGIBILITY:** The Your One Day At Disney Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia (“Territory”) who, as of the date of entry, are at least eighteen (18) years of age or the age of majority in their primary state of residence, whichever is older. Officers, directors, and employees, and members of their household (defined as people who share the same residence at least three (3) months a year, whether related or not) or immediate family (*i.e.*, parents, children, spouse, siblings, grandparents, step-parents, step-children, and step-siblings of each) and persons residing in such immediate family members' household, of Sponsor, Administrator, and their respective parent, related, affiliated and subsidiary companies, all other entities involved in the creation, administration, or fulfillment of the Sweepstakes and their respective successors and assigns are not eligible to enter or win. Winning is contingent upon fulfilling all requirements set forth herein. ***Void outside of the Territory, and where prohibited or restricted by law.***

Participation constitutes entrant’s full and unconditional agreement to these Official Rules (“Rules”) and Sponsor’s and Administrator’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

4. **HOW TO ENTER:** The Sweepstakes begins at 12:00:00 PM (noon) Eastern Time (“ET”) on November 1, 2019 and ends at 11:59:59 PM ET on December 2, 2019 (“Sweepstakes Period”). The Administrator’s computer is the official Sweepstakes clock.

A. GENERAL ENTRY: During the Sweepstakes Period, an eligible entrant (“Entrant”) must visit <https://onedayatdisney.disney.com> (“Website”) and submit either his/her e-mail address or log into his/her Disney account. Entrant must then follow the links and instructions to (1) complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code; and (2) select the Grand Prize (as defined below) he/she would like a chance to win. (Entrant only has to select the Grand Prize option one [1] time upon registration; Entrant will not be required to make another Grand Prize selection to receive Bonus Entries as defined below). Upon the successful submission of the registration information and Grand Prize selection, an entrant will receive one (1) entry (“General Entry”) into the Sweepstakes.

There is a limit of one (1) General Entry per person into the Sweepstakes during the Sweepstakes Period. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an Entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that Entrant, in Sponsor’s sole discretion, may be disqualified

and not be eligible to win a prize. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the Entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void.

B. BONUS ENTRIES: Following submission of the General Entry, an Entrant has two (2) ways to earn bonus Sweepstakes entries ("Bonus Entries") into the Sweepstakes as outlined below:

- 1. Make A Pre-Order Purchase:** During the Sweepstakes Period, an Entrant may pre-order the *One Day at Disney* book from shopDisney/Disney store, Amazon, Barnes & Noble, or Books-A-Million by purchasing the book through the links on the Website or by purchasing directly from their online and/or in-store locations ("Qualifying Purchase"), while supplies last. The Entrant must obtain and retain the receipt; print his/her name on the receipt; sign and date the receipt; and circle the Qualifying Purchase on the receipt before uploading the receipt. Then the Entrant must visit the Website and follow the on-screen prompts to upload a photograph of the original receipt showing the Qualifying Purchase. The file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 8 MB. Receipts must be submitted by 11:59:59 PM ET on December 2, 2019 to be valid. It is strongly recommended that the Entrant maintain possession of the original or photocopy. If the receipt does not reflect that the Qualifying Purchase was from shopDisney/Disney store, Amazon, Barnes & Noble, or Books-a-Million, then the Entrant will not receive Bonus Entries or the Bonus Entries will be voided. For each Qualifying Purchase receipt successfully submitted and accepted, an Entrant will receive ten (10) Bonus Entries into the Sweepstakes. There is a limit of up to three (3) Qualifying Purchases that may be submitted and up to three (3) unique receipt uploads during the Sweepstakes Period. An Entrant may not submit the same receipt more than one (1) time. Duplicated receipts will not be accepted. Receipts must be readable. Mechanical reproductions, altered receipts or unreadable receipts will not be accepted. Receipts submitted in excess of the limits set forth herein will not be accepted.
- 2. Mail-In Entry Without Making A Purchase:** To earn Bonus Entries during the Sweepstakes Period without making a purchase, Entrant may hand-write his/her complete name (no initials), valid e-mail address and telephone number on a 3½"x5" card ("**Mail-In Entry**" or "**Mail-In Entries**") and mail it with sufficient postage to: Your One Day At Disney Sweepstakes, P.O. Box 251328, West Bloomfield, MI 48325. All Mail-In Entries must be postmarked no later than December 2, 2019, and received on or before December 12, 2019, in order to be eligible. Mail-In Entries must be legibly hand-written and must be sent individually (multiple Mail-In Entries cannot be combined in one mailing). Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries. For each Mail-In Entry successfully submitted and accepted, Entrant will receive ten (10) Bonus Entries into the Sweepstakes during the Sweepstakes Period. There is a limit of up to three (3) Mail-In Entries during the Sweepstakes Period.

Other Bonus Entries Conditions: Regardless of method of obtaining Bonus Entries, there is a limit of thirty (30) total Bonus Entries into the Sweepstakes per person during the Sweepstakes Period. No Bonus Entries can be submitted or accepted until the Entrant's General Entry has been submitted and accepted. Any Bonus Entries submitted by an Entrant prior to the acceptance and submission of his/her General Entry will be voided and invalid.

NOTE: If an Entrant accesses the Website on his/her mobile device to enter this Sweepstakes, the Entrant's wireless service provider may charge the Entrant for applicable data charges. Entrants should consult their wireless service provider regarding its pricing plans. Message and data rates may apply. Entrants should review their mobile devices' capabilities for specific mobile application instructions.

- 5. WINNER SELECTION, NOTIFICATION, AND VERIFICATION:** On or around December 13, 2019, Administrator, an independent judging organization/administrator, will randomly select one (1) potential Grand Prize winner ("Grand Prize Winner") and five (5) First Prize winners ("First Prize Winners") (each a "Winner," and collectively, "Winners") from among all eligible General Entries and Bonus Entries received during the Sweepstakes Period. Administrator's decisions regarding the selection of the potential Winners are final and binding in all matters related to the Sweepstakes.

The potential Winners will be notified via e-mail at the e-mail address provided at the time of registration or associated with the Winners' Disney account with instructions on how to claim his/her prize. A Winner's acceptance of the prize shall constitute and signify the Winner's agreement and consent that Sponsor and its designees may use the Winner's name, city, state, likeness, photograph, video and/or prize information in connection with the Sweepstakes for promotional, advertising or other purposes, worldwide, in any and all media now known or hereafter devised, including without limitation, the Internet and without further payment, notification, permission or other consideration, except where prohibited by law.

The potential Grand Prize Winner will be required to execute an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, "Prize Claim Documents") within ten (10) calendar days from the date such Prize Claim Documents are sent to the potential Grand Prize Winner. The Grand Prize Winner's guest will also be required to sign and return a liability and/or publicity release(s) and other paperwork at the same time the potential Grand Prize Winner returns their Affidavit of Eligibility, Liability Release, Publicity Release and other paperwork.

At the sole discretion of Sponsor, disqualification, forfeiture and the selection of an alternate Winner may result from any of the following: (a) potential Winner's failure to respond to Sponsor's instructions; (b) the return of a notification as undeliverable; (c) potential Winner's failure to provide Administrator/Sponsor with satisfactory proof of age, identity and residency; (d) any non-compliance with these Rules; and (e) failure to execute and return the required Prize Claim Documents within ten (10) calendar days from the date such documents are sent to the potential Grand Prize Winner.

In the event that a potential Winner is disqualified or forfeits his/her prize for any reason, Sponsor may, at its sole discretion, award the prize to an alternate Winner selected by random drawing from among all remaining eligible General Entries and Bonus Entries. Each Winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her prize won. Sponsor will issue an IRS Form 1099-MISC for the Grand Prize Winner.

- 6. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:** As defined below, there will be one (1) Grand Prize and five (5) First Prizes (each a "Prize") available to be won in the Sweepstakes:

A. Grand Prize (1): The Grand Prize Winner will receive his or her choice of one (1) of the three (3) trips outlined below. The ARV of this trip Grand Prize option is \$10,000. The ARV of the GMA experience and the Disney store guest of honor experience is \$0. ARV may vary from actual value, depending on variables including but not limited to date and point of departure. Any difference between stated ARV and actual value will not be awarded. **Travel must be completed between February 15, 2020 and May 31, 2020.**
- ii. A Disney Cruise Line® vacation for four (4). This Grand Prize option consists of a five (5) day / four (4) night Disney Cruise Line® cruise vacation package to the Bahamas (the "Vacation Package" or "Grand Prize") for Grand Prize Winner and three (3) guests ("Guests" and together with the Grand Prize Winner, the "Group"), including: **[1]** round trip coach airfares for the Group between the Departure Airport and Orlando International Airport in Orlando, FL (an "Arrival Airport") provided that the Group resides outside a 200 mile radius of Port Canaveral, FL; **[2]** round trip ground transportation from Orlando International Airport to Port Canaveral, Florida, provided that the Group resides outside a 200 mile radius of Port Canaveral; **[3]** a four-night cruise to the Bahamas on the Disney Dream® Cruise Ship ("Ship") in one (1) stateroom (maximum capacity four [4] people; location/category at the discretion of Disney Cruise Line®); **[4]** all meals aboard the Ship (except Palo and Remy Fine Dining); **[5]** a special behind-the-scenes experience for the Group on the Ship as determined by Disney Cruise Line® (subject to Ship's itinerary, operating hours, availability and other restrictions) and **[6]** pre-paid gratuities, Taxes, Fees, and Port Expenses (as defined at www.disneycruise.com/taxesandfees). Items not included as part of the vacation package which are the responsibility of the Grand Prize Winner and Guests include: shore excursions; travel insurance; nursery charges; laundry service; spa treatments; alcoholic beverages; local and long distance telephone calls; ship to

shore communications including internet; merchandise and souvenirs; incidental expenses; additional tips and gratuities; income and other taxes; transportation between each Guest's home and gateway airport; airline baggage fees; and all other costs and expenses not otherwise mentioned herein. The ARV of this trip Grand Prize option is \$9,064.76. ARV of Ship's behind-the-scenes experience is \$0. ARV may vary from actual value, depending on variables including but not limited to date and point of departure. Any difference between stated ARV and actual value will not be awarded. **Travel must be completed between February 15, 2019, and November 30, 2020. Block Out Dates: 12/23/19; 12/30/19; 04/13/20; 04/20/20; 05/25/20; 06/01/20; 06/08/20; 06/17/20; 07/01/20; 07/13/20; 07/20/20 (Block Out Dates at the discretion of Disney Cruise Line® and subject to change).** Vacation fulfillment is subject to availability and restrictions at www.disneycruise.com. Travel may not occur during cruise ship or airline block-out periods. Each Guest in the Group is responsible for providing proper citizenship documentation to travel which may include passports, valid alien registration card and/or necessary visas. Those without proper citizenship documentation will be denied boarding. It is the Guests' responsibility to check with their travel agent, government agencies, embassies or consulates prior to their vacation to ensure that they have proper citizenship documentation. U.S. Citizens can also visit the State Department's travel website at www.travel.state.gov, or call the U.S. National Passport Information Center at (877) 4USA-PPT for more information. Guests of all ages are strongly encouraged to obtain passports.

- iii. A *Disneyland*® Resort vacation for four (4). This Grand Prize option consists of a three (3) Day / two (2) Night vacation package (the "Vacation Package" or "Grand Prize") for Grand Prize Winner and up to three (3) guests ("Guests" and together with the Grand Prize Winner, the "Group") to the *Disneyland*® Resort in Anaheim, California ("Resort") consisting of: **[1]** up to four (4) round trip coach airfares for the Group between the Departure Airport and a Southern California area airport (an "Arrival Airport" as determined by Sponsor in its sole discretion) provided that the Group resides outside a 200 mile radius of Anaheim, CA; **[2]** up to four (4) round trip ground transfers for the Group between the Arrival Airport, the Resort and The Walt Disney Studios provided that the Group resides outside a 200 mile radius of Anaheim, CA; **[3]** two (2) consecutive nights' accommodations (one standard room, quad occupancy) at a Resort hotel or Resort area hotel as determined by Sponsor; **[4]** up to four (4) 3-Day, 1-Park per day *Disneyland*® Resort tickets with Disney MaxPass (subject to restrictions); **[5]** services of a VIP Tour Guide for up to seven (7) consecutive hours (guide to be selected by Sponsor; subject to Resort operating hours and other restrictions); **[6]** a special Disney guided tour experience for the Group as determined by Sponsor (subject to Resort operating hours and other restrictions); **[7]** one (1) special dining experience for the Group at a Resort restaurant (restaurant and meal to be determined by Sponsor); and **[8]** a private tour of The Walt Disney Studios in Burbank, California ("Studios Tour") including round trip ground transportation from Disneyland Resort in Anaheim, CA to The Walt Disney Studios in Burbank, CA. The approximate retail value ("ARV") for the Vacation Package: \$10,000. ARV of the Studios Tour is \$0. Actual value of the vacation package may vary depending on Grand Prize Winner's point of departure and fluctuations of hotel rate and airfares. Any difference between the stated ARV and the actual cost of the Vacation Package will not be awarded. **Travel must be completed between February 15, 2020 and May 31, 2020.** Disney MaxPass is subject to additional terms and conditions (see

General Conditions for Each Grand Prize: All airports, airline carriers, flights (including any possible stopovers/layovers), and ground transportation will be selected by Sponsor in its sole and absolute discretion. Each Grand Prize option consists of only the items specifically listed above as the prize. A Guest under the age of majority must be accompanied by his/her parent/legal guardian who must be at least the age of majority and both will be deemed Guests of the Grand Prize Winner (unless the Grand Prize Winner is the Guest's parent or legal guardian). Group must possess required travel documents (e.g. valid Photo ID) prior to departure and air transportation must be round-trip from/to the same Departure Airport/Arrival Airport. Each member of the Group will be required to execute a liability/publicity release form prior to booking of any travel. Failure to return the executed release form within the specified time period will result in forfeiture of the Vacation Package. - B. First Prizes (5):** Each First Prize Winner will receive a First Prize package ("First Prize") which includes one (1) *One Day at Disney* book, one (1) *Disney* promotional tote bag and one (1) \$200 Disney Gift Card (subject to terms and conditions at www.disneygiftcard.com). No more than five (5) First Prizes will be awarded in the Sweepstakes. The ARV of each First Prize is \$250.
- C. Total ARV of All Prizes:** The total ARV of all prizes in the Sweepstakes ranges from \$10,314.76 to \$11,250, depending on Grand Prize Winner selection.
- D. Odds of Winning:** The odds of winning a Grand Prize or First Prize in the Sweepstakes depend on the number of eligible General Entries and Bonus Entries received during the Sweepstakes Period.
- E. Prize Conditions:** In no event will more than one (1) Grand Prize and five (5) First Prizes be awarded. Limit: There is a limit of one (1) prize per person.

By accepting the Prize, each Winner agrees to release and discharge Sponsor, Administrator, and their respective parent, related, affiliated, and subsidiary companies and their respective officers, directors agents, employees and assigns from any and all legal claims, losses, injuries, demands, damages, actions, and/or causes of action that arise out of and/or are in any way related to the Prize, the receipt, use and/or enjoyment of the Prize, any Prize-related activity, and/or the Sweepstakes. Sponsor and Administrator bear no responsibility if any event, element or detail of a prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of a prize become unavailable, the Sponsor shall have no obligation to any Winner aside from providing his/her prize, minus any unavailable event, element or detail.
